Global Technocracy: How the New World Order Is Being Built Through “Build Back Better”

The glorious governmental system the Founding Fathers devised through divine inspiration has no equal in terms of providing an environment of freedom for its citizens to prosper. Americanism was created and implemented to protect our God-given rights and to limit the government, not the people. It’s a system that our enemies must overcome if they are to control us. To do so, an ever-increasing level of government must be in place — particularly a federal government operating outside of its limitations, along with unaccountable bureaucracies both inside the federal government and outside in the form of regional governmental bodies.

As former JBS CEO Arthur Thompson covered in his excellent overview of the Council on Foreign Relations, *In the Shadows of the Deep State*, our enemies looking to overthrow freedom have deep-rooted origins. Out of the Illuminati came connections that reached to Karl Marx and Frederick Engels. Both authored a book called *The Holy Family*, published in February 1845. As Mr. Thompson wrote, this book was written “three years prior to ‘The Communist Manifesto.’”

In *The Holy Family*, Marx and Engels wrote, “The revolutionary movement which began in 1789 in the Cercle Social ... gave rise to the communist idea ... re-introduced in France after the Revolution of 1830 This ... is the idea of the new world order.”

Boiling it down, advocates of the New World Order seek to create a world government that all countries would be subservient to. Yet, this world government would not be some mere body above our own federal government that helps to resolve problems with other countries. No, it would have complete control and would also be the final authority in domestic affairs. Think of it as the European Union on steroids.

While the New World Order pushed by Marx and Engels was socialist and communist in nature, the actual structure of what the world government would look like is

very much in flux. The best contemporary examples include the United Nations and the regional unions (with unaccountable bureaucracies) that many countries are embroiled in. However, as Alex Newman reported in his video “New World Order = Global Technocracy” on TheNewAmerican.com, the New World Order may be neither capitalist nor communist in nature. Rather, it will be a technocracy. Mr. Newman explains it would get rid of individual liberty in exchange for “saving” the environment. All of this would be run by technocrats, including scientists and engineers, under the control of the elite.

The pioneer researcher of technocracy is Patrick Wood, with his seminal books *Technocracy Rising: The Trojan Horse of Global Transformation* (2014) and *Technocracy: The Hard Road to World Order* (2018).

As Mr. Newman explains in his video, Mr. Wood’s newer book detailed a definition of technocracy from advocates in 1938 as, “The science of social engineering; the scientific operation of the entire social mechanism to produce and distribute goods and services to the entire population.” Mr. Newman rightfully interpreted this as a direct attack on private property, money, and the free market-based economy. The goal is to exchange these for various other items to transition to a resource-based economy (think central planning). The scientific community and other technocrats would determine what is produced and how it is produced and distributed according to efficiency, environmentalism, and community needs.

Advocates of this type of scientific dictatorship are not just found on the proverbial left. Technocracy has made inroads with certain conservatives and libertarians through at least two widely popular online “documentaries”: *Zeitgeist: The Movie* and *2030 UnMasked*. As is usually the case, there are some salient points made in the videos, but there’s lots of garbage sprinkled in between. At the end of each of these videos, a pitch is made for technocracy.

Advocates have made arguments for environmental protection, Earth’s carrying capacity, and, of course, a resource-based economy.

JBS publications have been exposing the buildup

to this for many decades. One of the earliest mentions was in the March 1962 issue of *American Opinion*, in an article titled “The European Common Market” by Hans F. Sennholz. He was sounding the alarm bell of the market’s working “towards the development of an international economic bureaucracy with its central planners, statisticians, econometricians, and technocrats, with international investment control and all the rest.” While the planners succeeded in doing so, Mr. Sennholz also pointed out in the article, “The growing popularity of the European Economic Community must be seen in the light of American foreign trade debate. Many Washington voices seem to imply that all we have to do to solve our foreign problems and such domestic problems as economic stagnation, gold and dollar problems, and unemployment is to reduce our tariff barriers and team up with the European Common Market. Pressures are mounting for our entry into the Common Market.”

This globalist/internationalist push of the 1960s has only strengthened in subsequent years, and has advocates on *both* sides of the political aisle. As Senator George Malone exposed in his 1958 book *Mainline*, trade is used as a bludgeoning tool to

overcome a country's sovereignty and help create a New World Order.

In 1970, elite globalist Zbigniew Brzezinski wrote *Between Two Ages: America's Role in the Technetronic Era*. According to the November 1977 issue of *American Opinion*, he wrote in it, "Marxism represents a further vital and creative stage in the maturing of man's universal vision. Marxism ... is a victory of reason over belief."

No matter how new the proposed system to replace our current one may seem to be, it always comes back to what JBS Founder Mr. Robert Welch described as our "fatal struggle for freedom against slavery, for existence against destruction." And when you peel back the curtain, you will find evil manifesting itself, usually through humanity's old foe of communism.

According to a 1988 article in *The New American*, in his book Brzezinski promoted "'a global tax system' to support a world government." The Sixteenth Amendment established an income tax in 1913, giving the federal government half of the equation it needed to ensure a steady stream of income into its coffers. The other half was done later that same year through the establishment of the Federal Reserve (it is usually pointed out that there is nothing federal or reserve about it!).

As Clarence Carson wrote in an article in the July 8, 1981 issue of *Review of the News*:

The Federal Reserve finances the government deficit by buying securities and flooding the country with paper money. In consequence, prices, wages, and incomes rise. As income rises, taxpayers move into higher tax brackets.... The political advantage of this setup is that government revenues can increase by hundreds of billions of dollars without any change in the tax rates. Indeed, government revenues will likely increase much more rapidly than does the rise in prices, thanks to the graduated feature of the tax....

Knowing that the Fed and the income tax work together to redistribute wealth in America, global-government advocates have been salivating at the prospect of replicating this on a global scale to help build world government infrastructure and programs. While the Fed has been all too happy to inflate the currency supply whenever called upon for help (as exposed by the 2010 limited audit authorized by the Dodd-Frank Act), a worldwide tax system would give globalists a reliable source of revenue to accelerate implementation of their programs.

For several years, globalists in the Organization for Economic Cooperation and Development (OECD) have been working on establishing a global minimum corporate tax rate. In early October, it announced an agreement between 136 countries, including the U.S., that "will fundamentally transform the international tax landscape within which multinational enterprises operate by reallocating certain profits to markets and by putting a floor on tax competition so as to ensure that at least a minimum amount of tax is paid," according to the October 2021 "OECD Secretary-General Tax Report to G20 Leaders."

As *The New American* reported, "President Joe Biden, a cheerleader for the new agreement, cited it as 'proof that the rest of the world agrees that corporations can and should do more to ensure that we build back better.'"

The OECD envisions a "two-pillar solution" that will bring in \$275 billion annually once both pillars are implemented in 2023. According to the OECD, "Pillar One will ensure a fairer distribution of profits and taxing rights among countries with respect to the largest and most profitable multinational enterprises. It will re-allocate some taxing rights over MNEs [multinational enterprises] from their home countries to the markets where they have business activities and earn profits, regardless of whether firms have a physical presence there."

"Pillar Two introduces a global minimum corporate tax rate set at 15%. The new minimum tax rate will apply to companies with revenue above EUR 750 million Further benefits will also arise from the stabilisation of the international tax system and the increased tax certainty for taxpayers and tax administrations."

The logistics of how this will be accomplished have not been released, but Alex Newman has exposed the International Monetary Fund and the United Nations as being "at the center of these global financial manipulations." His exposé of global taxing efforts was published in the April 21, 2014 issue of *The New American*. As Mr. Newman pointed out, the IMF "literally looted the bank accounts of private individuals in Cyprus as a trial run at worldwide wealth confiscation."

The IMF could certainly be the vehicle to collect the tax, assuming that each participating government goes along with it, ceding sovereignty and privacy rights to a global institution operating outside of each government's accountability.

Let's realize that corporate taxes are merely the beginning. Given the precedent set in Cyprus, having the IMF reach into Americans' accounts for a "Climate Change Tax" may not be too much of a stretch to further fund the infrastructure of global government.

We can fathom that many governments will quickly join the effort, while others will fold to the pressure, passing supporting legislation. Even our own Congress has a good chance of folding, unless there is significant support to stop it. Congress has displayed quite an appetite for globalist programs, especially trade agreements that have linked both sides of the political aisle, as seen in the passage of the United States-Mexico-Canada Agreement during President Trump's term.

Technocracy is not a passing fad. It's been discussed since the 1930s and advocates are now ramping up their efforts. But we're not even scratching the surface here. In a new book coming out at the end of this year, Dennis Behreandt, publisher of *The New American*, offers a jaw-dropping look at where technocracy is heading. The book is tentatively titled *End Game: An Examination of the International Elites' Trend Toward Ending Humanity as We Know It*. It looks at the rarely spoken but disquieting topics of transhumanism, eugenics, population reduction, and related technologies that form the basis for the way the New World Order elites are taking technocracy and tyranny to whole new levels.

Let's keep in mind that to stop this, there must be an organized effort to do so. This is why we are here — to expose this type of slavery before it gets forced upon the American people; to stop these evil and diabolic plans, preserving the great experiment of freedom started by the Founding Fathers so long ago; and to restore Americanism, so it too can reach its potential, serving as a shining example of what free people can accomplish.

We must prioritize the solution: working to get America out of globalist institutions like the United Nations. We must once again dedicate substantial time and resources in building support to *Get US Out!* We must generate substantial pressure for Congress to make this a priority. How do we do it? Exactly as we've always done it: Birching!

Let's outline some of the steps we can take:

1. Work locally, educating our local communities and the electorate as a whole.
2. Work through the state legislatures.
3. Work at the federal level.

We should apply the majority of our efforts to Step 1, working locally. Then focus as much time and effort as possible on Step 2, influencing our state legislators. Over time, working in these areas should reduce the amount of work necessary at the federal level.

Our 100/10/6 program was created as a way to distribute our TRIM (Tax Reform Immediately) bulletins in the 1990s, and it proved to be very beneficial in building influence and educating electorates. If you're not familiar with this concept, read Midwest Regional Field Director Robert Owens' great summary of it in the "Recruiting" column in the August 2021 *Bulletin*. You can find archived copies of the *Bulletin* in the Members Area of JBS.org.

Also, our video *The Power of 500* highlights the concept and how to apply it. Please review this and share it with others. It's on the JBS YouTube account (<https://youtu.be/47vf04LIHYY>), as well as in the video section of JBS.org (<https://jbs.org/video/join-the-power-of-500-informed-electorates-that-work/>). Furthermore, we are working on new resources to help you carry out the 100/10/6 program.

Working locally means Chapter activities geared toward raising awareness of the problem of globalism, how the United Nations is a major hub, and how "Build Back Better" — which originated as a globalist UN slogan and program — is Biden's agenda to replace Americanism with globalism.

Over the years, we have made significant inroads in educating the public on the dangers of the United Nations. Now it's time for this to become a pivotal program that exposes and stops "Build Back Better." With your help and leadership, we will see this come to fruition. Look around; the opportunities are endless, but begin *locally*. Happy Birching! ■

B. Stop the New World Order

The Real Agenda Behind the UN's COP26 Climate Conference

In some ways, the COP26 conference, held in early November in Glasgow, Scotland, was predictable. World leaders warned about a pending climate catastrophe while using their carbon-spewing private jets to get to and from the event. Other aspects were more sinister; for example, 80 countries, including the United States, endorsed a plan to integrate national power grids — undermining national sovereignty — in the name of fighting climate change.

But to grasp the full meaning of COP26, one must understand the threat to freedom posed by the United Nations, among other international groups. COP26 is the 26th annual UN-arranged gathering of representatives of the world's nations to study and devise solutions to what was originally termed "global warming" and is now addressed as "climate change." COP stands for "Conference of Parties," the original name of the annual gathering.

The media and the Deep State have relentlessly drilled the "climate crisis" narrative into the public's thinking, so much so that many now accept it as fact. But many climatologists disagree that human activity, such as the burning of fossil fuels, is causing an increase in the Earth's temperature. Furthermore, they and others note that carbon dioxide is needed to grow food and has never been a threat to mankind's survival.

A hard look at what COP26 is really designed to accomplish will reveal it to be a promotion of international control of human activity that ultimately will enslave the world's people. It's that simple and that sinister.

There are, unfortunately, real threats to freedom being promoted by the UN and its associated organizations. A. Stop the Con-Con

In 2022, Focus on Defeating and Rescinding Con-Con Applications

The legislatures of most states will reconvene in January of next year. For patriots, this presents both an opportunity and a challenge: an opportunity to advance legislation that protects and restores our God-given individual freedoms, and a challenge to stop measures that do the opposite.

One of the most important battles in state capitols this coming year is over state applications for a constitutional convention (Con-Con), under Article V of the U.S. Constitution. Pushed by organizations such as Convention of States (COS) and Wolf-PAC, a convention risks opening up the Constitution to radical revisions that would decimate our individual freedom. It is imperative that we defeat this insidious threat.

Although patriots in every state must stay on guard against Con-Con activity, there are some states we must watch particularly closely. In multiple states, Con-Con resolutions have passed either the state house or senate, and risk passing the other. These include Georgia (SR 28 and SR 29), North Carolina (H172, H233), South Carolina (H3205), Tennessee (HJR 8), West Virginia (SCR 5), and Wisconsin (AJR 9). Furthermore, Nebraska's unicameral legislature is at risk of passing COS resolution LR 14. Other Con-Con resolutions have been introduced in most of these states. We cannot afford to be complacent or let down our guard in these states.


Other states are also at serious risk of considering or passing Con-Con resolutions next year. They include — but are not limited to — Arizona, Iowa, Kansas, Kentucky, Michigan, Ohio, Pennsylvania, South Dakota, and Wyoming. These states have seen much Con-Con activity in the past year and look poised to pass resolutions — if patriots don't act decisively.

However, being on defense with no offense is a poor strategy that will ultimately result in defeat. In addition to stopping new Con-Con applications, we must focus on rescinding existing ones. Already, two states — Nebraska (LR 28) and North Carolina (HJR 146) — have pending rescission resolutions that patriots must urge their legislators to pass. In North Carolina, a potential selling point to the Republican-controlled legislature is the fact that in 1949, the state applied to Congress for a convention to propose amendments implementing a world federation and a world constitution. This application has not been rescinded.

Other ripe rescission opportunities include Illinois, Kentucky, New Jersey, New York, Oregon, and Washington, which have antiquated resolutions that Balanced Budget Amendment (BBA) advocates are aiming to use to advance their particular Con-Con scheme. Most of these states' legislatures are Democrat-controlled and could be convinced to support rescission. States that either recently defeated Con-Con resolutions or have seen opposition to a convention among influential opinion molders — including Alabama, Montana, North Dakota, and Wyoming — also present strong rescission opportunities.

If we are to save our Constitution, patriots in any of the above states must actively be in contact with their legislators and the relevant committees — not only to oppose a Con-Con, but to educate legislators about superior alternatives. Rather than pursuing a dangerous method that could lead to radical amendments or an entirely new constitution, legislators

would be wise to enforce the Constitution, such as nullifying unconstitutional federal actions under the Constitution's Article VI, which obligates such actions. For examples of how nullification has been used successfully both historically and recently, visit <https://jbs.org/6not5/6not5-action/>.

In addition to enforcing the Constitution through nullification, state legislators must put their energy into ending their dependence on the federal government for funding. Further, rather than using term limits to throw out congressmen who don't follow the Constitution, the electorate needs to be educated to stop electing such individuals. All of these solutions are significantly more effective than a Con-Con at advancing positive change.

As 2022 begins, let's not get complacent about the Con-Con threat. Rather, in addition to actively working to stop new applications, let's advance rescission resolutions and positive alternatives such as nullification. Through education and coordinated action, we will win the battle for our Constitution.

ACTION SUMMARY

- Regularly get in contact with your legislators and educate them on the dangers of a Con-Con and the benefits of alternatives such as nullification.
- If you live in one of the states listed above with pending Con-Con resolutions, work to stop the measure(s) in your state. Furthermore, work on getting a resolution introduced and passed in your state to rescind all existing Con-Con applications.

E. Restore Election Integrity

Political Theater — Texas Size

Texas's much-publicized Election Integrity Protection Act started out as a good bill, but morphed into yet another "election integrity" bill that took one step forward and two steps back. In its original state, it was a huge step in the right direction. It passed the Texas Senate and went to the House. Election integrity advocates were elated, but that euphoria didn't last long.

Then came the political theater. Act One occurred on March 25 when the House Elections Committee was scheduled to hear testimony on HB 6, a House bill on election integrity. It was considerably weaker than SB 7, the original iteration of the election integrity bill. Multiple election integrity advocates traveled to Austin, some of them staying overnight, just to get a few minutes each to testify in favor of HB 6 with hoping to see it modified to be more like SB 7. Their money and time were wasted. At the beginning of the hearing, Elections Committee Chair Briscoe Cain gave the gavel, supposedly temporarily, to committee co-chair Jessica González (D-Dallas). Once Cain had finished answering questions about the bill, he attempted to regain his position as chair of the hearing, but González refused. Cain did regain his position as chair of the hearing by moving for a recess, which was passed, but because he hadn't included an ending time for the recess, it became an indefinite recess and the hearing ended with no action. This was a huge blow to the election integrity advocates, especially those who spent time and money going to Austin to testify.

Act Two of the political theater in Austin started as that session ended. The House Calendars Committee scheduled the election integrity bill last on the agenda. That's when the Democratic legislators walked out of the House, creating a lack of quorum. The theatrics made it appear that the Democrats outsmarted the Republicans, but it was actually the Republicans who enabled them by slow-walking the election integrity bills, stalling them in committee while prioritizing the passage of special-interest legislation. The walkout continued into the second special session.

The mainstream news media covered the theatrics, including the legislative walkouts, but gave very

little coverage to the major changes to the bill that were occurring behind the scenes. Another reason the changes have been so well hidden is because the original Senate-passed bill was 38 pages long, while the final bill, numbered as SB 1, was 76 pages. One change alone should raise questions — the final bill twice referred to our form of government as a "constitutional democracy."

Here are just a few of the changes: Poll watchers, rather than being empowered, are further hampered under the new bill. Traditional American elections were open to the public. Anyone who wanted to walk in and observe the voting or vote count was welcome to do so. There were no prohibitions against photography. All that was necessary was that the person not be disruptive. Under current law in Texas, poll watchers need to be appointed, and no electronic images or sound recordings are allowed. This suppresses the gathering of evidence. Under the original wording of SB 7, poll watchers were to have those recording rights restored, and even have a process by which such evidence could be transmitted immediately to the secretary of state's office if the poll watcher had reason to believe there were violations of the law.

Guess what happened while the public was distracted by the theatrics? The restoration of the right of poll watchers to make recordings was removed and further suppression of poll watching was inserted. From now on, no one will be allowed to be appointed as a poll watcher unless he has completed a training course run by the secretary of state's office and has a current certificate. Government certification of poll watchers was high on the wish list of many liberals. This will pull the rug out from under many attempts at poll watching.

But it gets worse. The new version of the law requires observers to "observe without obstructing the conduct of an election" and not to interfere. That sounds reasonable at first, but many poll watchers in Texas have been falsely accused of obstructing or interfering in the process by poll workers who deliberately got in the way of the watchers. Under the new law, there will be a process for the election officials to call law enforcement to remove poll watchers. Without the ability to record images or sound, how can the poll watchers prove themselves innocent?

Many other election integrity provisions were altered behind the curtain. Under the original bill, anyone who simultaneously assists three or more voters (other than relatives) with transportation would need to fill out a form. This was designed

to curb drive-through voting by the carload. The number "three" was changed to "seven" while the public was distracted by the theatrics. Unfortunately, the examples mentioned above are not the only such behind-closed-doors betrayals.

Many politicians, including Republican legislators, are touting this bill as an improvement as they seek reelection. Perhaps they haven't read it, or perhaps they don't understand traditional American election integrity. Electing informed and responsible legislators starts with an informed public. If you are not currently involved in a Restore Election Integrity committee, then consider creating or joining one. Don't expect any political party to save America or clean up our elections. Remember the words of Professor Carroll Quigley in his book *Tragedy and Hope*: "The two parties should be almost identical, so that the American people can 'throw the rascals out' at any election without leading to any profound or extensive shifts in policy."

Support **H.R. 3860 to End Tyrannical Military Vaccine Mandate** (contact your congressmen)



Make the Most of Local and Social Media

newspaper in Kingman, Arizona, published an article titled "John Birch Society gets Kingman chapter."

"The Kingman chapter of the John Birch Society, with a 'foundation in the Declaration of Independence, the Constitution and a belief in God who endows each person with rights,' aims to educate locally while making national and international impacts," the lead reads. The reporter goes on to quote Kingman JBS Chapter Leader Kris Rodarte, who explains how that Chapter came about and what the JBS is about. The article is fair, even when it mentions the negative publicity the JBS has received in the past.

This is a good example of how we can help spread the word about our local Chapters by using local media. While Birchers, of all people, have good reason to be skeptical of the news media, given the fractious history between the media and the JBS, keep in mind that there are many small newspapers all across the country run by normal people with no connections to leftist Big Media — people who are part of the community they write about.

If there is a local paper nearby, we encourage you to reach out to the editor next time you have an event, or for other newsworthy reasons. Write the editor an

email or visit him in person. Let him know about your local Chapter and the work you are doing, and ask if he would like to cover it.

Of course, there is a risk. If you know for sure that your local newspaper is run by raging leftists, you might as well save your efforts. But if you're not sure, or if you have reason to suspect that your local paper is run by reasonable, objective news people, it might be worth the risk to try to get exposure. If successful, this can help your Chapter's influence.

Also, we'd like to encourage Birchers who are already active on social media to regularly share JBS and TNA content on your personal social media page. Since Big Tech shadow-bans and outright restricts our content, we already have an uphill battle. But if the Bircher army provides an organic social media "boost," it would help offset the censorship efforts of Big Tech.


